# Access, Inclusion and Belonging:

- Commission outreach materials have been translated or interpreted into California's top 14 languages. Every commission meeting has been interpreted into American Sign Language (ASL) and captioned in written English for the Deaf and Hard of Hearing community.
- Seven+ Commission presentations were in Spanish or fully interpreted into Spanish and the *Redistricting Basics* presentation is available in Spanish on YouTube.
- Rural, agricultural, LGBTQ, incarcerated and socio economically challenged communities have all had focused outreach and have hosted Commission presentations.



Outreach has already led to more than *483 individuals submitting input*, by late June 2021, via phone, email, public input meeting and online, about where to draw the lines in California in 2021, with every one of the Commission's outreach zones represented at its first public input meeting on June 10th.
